This full amount was donated to Union Gospel Mission for a summer backpack program serving children in need. Food scarcity is higher in the summer months when children do not have access to school. Backpacks containing non-perishable food items were assembled once a week and sent with children on weekends, when summer programs are not available. Approximately 1,750 children were given a backpack containing 14-15 shelf stable food items that required minimal preparation. These backpacks were provided in outlying rural regions, where other resources are less readily available.

4b (Code:) (Expenses \$ 20,000 including grants of \$ 20,000) (Revenue \$)

The YMCA maintained a backpack program that distributes primarily to the inner city of Duluth, MN. In addition, they provide meals for children on site.

4c (Code:) (Expenses \$ 10,000 including grants of \$ 10,000) (Revenue \$)

The full amount was donated to the Diamiano Center Kid's Kitchen, which serves children who experience food scarcity in the home or if housed in homeless shelters. The center serves primarily the inner city, downtown area of Duluth, MN.
